
- Healthcare: Easy access to high-quality healthcare is crucial. Look for cities with reputable hospitals, clinics, and geriatric care specialists.

2023-2024 Best Places to Age in Place Methodology

How We Rank the Best Places to Retire and Age in Place

Rankings for this Zemplee report are based on an analysis of public data. Rankings for 122 metropolitan areas in the U.S. were created from a composite score based on 3 primary factors. We created a set of criteria directly or indirectly indicative of the cost, health, and quality of living of senior populations in these U.S. metropolitan areas to determine the top cities to age in place. The 3 primary factors considered are Cost of Living, Healthcare, and Quality of Life. Each factor's score is made from 2-5 indicators. The primary factor rankings were analyzed by calculating a normalized score for each factor and the overall ranking comes from the weighted sum of the normalized scores. Each factor was weighted in the final sum. From these cities, each was scored and ranked by state-level Cost and Healthcare data and city-level Quality of Life data.

The 3 primary factors were given different weights to calculate the cumulative score as follows: Cost of Living- 30%, Healthcare- 40%, Quality of Life- 30%.

122 Cities were sourced between these two lists for best states to retire* (Forbes; Sperling, 2015). From these cities, each was scored and ranked by state-level Cost and Healthcare data and city-level Quality of Life data.

*Cities from Alaska and the District of Columbia were not included in the analysis due to lack of Healthcare/Medicare data.

Each of the factors and their indicators is described further below:

Cost of Living- 30% weight

Each indicator was weighed at a different weight to calculate the final Cost of Living score for each state.

Cost of Living Score

 This is an indicator of the total of all the cost of living subcategories (housing, utilities, grocery items, transportation, health care, and miscellaneous goods and services) compiled into a single value. State and local taxes are not included in any category. Data was provided form the Council for Community and Economic Research (Missouri Economic Research and Information Center).

State Tax and Avg Local Tax Combined

This indicator is based on the percentages, or rates, for each state collected from the most recently
available data. This is an indicator of the average combined state and local sales tax rate. The majority of
rates represent data collected up to 2023 (Walczak, 2024).

State Tax on Social Security:

 This indicator accounts for whether or not the state has taxes on social security. Each state with taxes on social security has their own rules and regulations. We recommend checking your state and local tax bureau website. States were assigned a 1 if they have any state or local tax on social security and a 0 if not (Washington, 2024a).

State Tax on Pension:

This indicator accounts for whether or not the state has taxes on pensions. Each state with taxes on
pensions has their own rules and regulations. We recommend checking your state and local tax bureau
website. States were assigned a 1 if they have some sort of state or local tax on pension and a 0 if not
(Washington, 2024b).

Healthcare- 40% weight

Each indicator was weighed at a different weight to calculate the final Healthcare score for each state.

Health Outcomes for Seniors

• This indicator ranks each state particularly on senior health outcomes taking into account Behavioral Health, Mortality, and Physical Health (United Health Foundation, 2024).

Percentage of State Population in Healthcare Employment

 This indicator measures the percentage of the population in a state that are employed in Ambulatory Health Care Services, Hospitals, and Nursing and Residential Care Facilities as reported by the Bureau of Labor statistics (Kaiser Family Foundation, 2023; Visual Capitalist, 2023).

Percent of Plans Rated 4 Stars or Higher,

Average In-Network Out-of-Pocket Spending Limit,

Average Monthly Medicare Advantage Prescription Drug Plan Premium

These three indicators are from a report determining where Medicare beneficiaries have
access to the widest range of quality private Medicare plans at the most affordable prices. The
report compares plan data from the Centers for Medicare & Medicaid Services (CMS) for 50
states, using affordability and cost (MedicareAdvantage.com, 2024).

Quality of Life- 30% weight

Each indicators below was weighed equally to calculate the final Quality of Life score for each city.

Percent of Seniors in City Population:

• This indicator measures the percentage of seniors in the state population (U.S. Census Bureau, 2021; World Population Review, 2024).

Climate:

This indicator scores cities by their average lowest temperature (warmer = higher ranking).
 Each city's weather score was determined using the Best Places weather comparison tool (BestPlaces).
